## **Project presentation**

Since October 2021, six partners from France, Italy, Greece, Slovakia, Bulgaria, and Portugal have been collaborating to share their knowledge and experience within the framework of the European Erasmus+ Work4Future project.

The aim is to develop four tools to support entrepreneurs, SMEs, managers, and remote workers to get the most of smart remote working as fully motivated staff member.

What are such tools?

**Work4Future Training Framework** defining the main parameters and methodology used for the Training course scope coverage.

This comprehensive resource provides the basis for the project two guides, namely Guide on Team Management and Guide for Coaches.

The Training Framework is available in English in the project website: <u>Work4Future Training Framework</u>.

**Work4Future Guide on Team Management** offering practical strategies to foster productive and collaborative teams in the context of remote working, focusing on six tools including (i) Psychology and positive thinking, (ii) Communication in the virtual environment, (iii) Work etiquette in the remote working era, (iv) Work-life balance, (v) Best coworker and (vi) Practical exercises and games. The <u>courses</u> are available in English.

**Work4Future Guide for Coaches** providing resources and techniques to help managers and coaches unlock their full potential when exploring the Guide on Team Management and Work4Future platform.

The Guide is currently being finalized and will soon be available on our online platform.

## Latest project news

In March 2023, Work4Future partnership gathered in Campobasso (IT) for a "train the trainer" event. This event gave the partners the opportunity to conduct project activities with VET professionals and to finalize the project results.

In **June 2023**, partners met in Lisbon to finetune the tools and materials, including the online platform in all national languages to prepare forthcoming piloting with project target groups.

From July to September 2023, piloting sessions will take place in each partner country. Such sessions will involve a sample of participants representing the project final beneficiaries, including entrepreneurs, SMEs, managers and remote workers. The aim is to test Work4Future developed tools available on the project platform and to gather valuable feedback for further improvements.

Following the piloting sessions, partners will consider the collected feedback in order to finetune the project tools. The insights gathered from piloting will then contribute to finalize the tools and make sure that they meet effectively the project target group's needs.
